How To Hyperlink Your Email Signature

Within Microsoft Outlook:

Select "New E-mail"

Within the pop-up window titled "Untitled - Message (HTML)" select the "Signature" option along the menu at the top of the pop-up. When you select this menu option you should see options to choose an existing signature to add to the new email, but at the bottom is the option to select "Signatures".

Within the pop-up window titled "Signatures and Stationery" under the subtitle "Select signature to edit", either select a current signature to edit or create a "New" option below the window.

The selected signature appears in the main display area of the pop-up window. If you selected the "New" option, a small pop-up appears titled "New Signature" prompting you to type a name and select "OK".

To set up a hyperlink to a web page or site, select the small symbol of the globe and chain at the far right-hand side of the pop-up window main display area subtitled "Edit signature" that is displaying the signature you are editing or creating.

A new pop-up window should appear with the title "Insert Hyperlink". Across from where it says "Look in:" pick the small symbol of the globe and magnifying glass. This should bring up an internet browser window for you to navigate to the website of page of your choosing. Once on the desired page in your internet browser highlight the entire address and right click with your mouse to bring up a small option pop-up and select to "copy".

Back in the "Insert Hyperlink" pop-up window point your cursor to the "Address:" window near the bottom of the pop-up and right click your mouse to bring up a small option pop-up and select to "paste". Back at the top of the "Insert Hyperlink" popup window, triple click the duplicate web address in the "Text to display:" window and type however you wish the text to any know ledge of or approval of advertisers products or services.

We Welcome Members to Submit Articles

Include articles on topics of interest to your readers, relevant news and events. If you find an interesting article on the Web, you can easily ask the author's permission to summarize the article and link to it from your newsletter. Inserting a link in your article lets you track which topics attract the most interest.

Proofers Wanted!

The Communications Committee is always seeking proofreaders for the APA newsletter and other APA communications. If you are knowledgeable, talented, and interested in grammar, spelling, sentence structure, etc., please contact <u>Nina</u> <u>Paquette</u>. appear in your signature for the hyperlink. If you are satisfied, select "OK" at the bottom right corner of the window.

You have now added hyperlinked text to your signature shown in the pop-up window titled "Signatures and Stationery". This hyperlinked text can now be moved and adjusted to edit or build your signature as you want. When done select "OK" at the bottom right corner of the window, now place your edited or created signature in an email to test.

Jim Boyce Memory

Many of our newer members never had the chance to know Jim. It is understandable that they may not know why the scholarship we offer is named for him. Over the years, we have lost other dear friends and colleagues. The scholarship honors them all, but Jim was not only the first colleague we lost, but a pioneer in accessibility in the state. Perhaps a future article can elaborate his history, but I would like to share one event that demonstrates the personality that we cherished when he was with us.

As an inexperienced architect in 1977, I first met Jim while working on a school project. In those days, state accessibility law was limited to buildings constructed or renovated with public funds. Starting in 1971, such buildings were required to have plans submitted for review and approval. (Strangely, there was no tracking system or enforcement mechanism in place.)

Being completely ignorant of the requirements in 1977, I called and set an appointment with Jim at the State Building Commission to explain the review notes I had received. I had a hard time finding the office buried among other agencies, so I arrived late, right at lunchtime.

I offered to return after lunch, but Jim told me to sit and open up the review and plans. As I dutifully spread out the plans, he took out his brown bag lunch and thermos. Looking for a place on the cluttered desk, he opened the thermos and poured a cup of coffee as we began going through the notes. Soon, he reached for the bag, pulled out a sandwich and offered half to me while we talked. Now that was not the type of bureaucrat that I was used to. What started out as an explanation of review notes turned into an hours long lesson in accessibility. Jim's kindness was soon apparent, and his passion both for accessibility and for sharing was evident. I called him several times over the ensuing years to ask questions about the Texas Standards. He was never too busy to explain the application, as well as the rationale of the text.

It was over eighteen years later that I met Jim again. I was seeking to be an Independent Contract Provider, and he was my instructor at the Texas Accessibility Academy. He was still the same exceptionally kind person I had first met over a shared sandwich in a cluttered alcove, and his passion for teaching was still evident.

The scholarship is named for Jim Boyce because he exemplifies the best of all of us in APA. I look around me at an annual meeting and see people who are equally passionate, knowing that the work they do will make a difference for generations to come.

Jim was formerly a Plan Review Manager with the Texas Department of Licensing and Regulation (TDLR) and was one of the drafters of the Texas Accessibility Standards (TAS), in 1994. When Jim retired from TDLR, he became a Registered Accessibility Specialist (RAS) and was among the Charter Members of APA. The success of APA is in large part due to Jim's leadership in its earlier years.
